



In 1985, Schoongezicht was zoned as a residential sectional title complex of 66 units. It is maintained in accordance with the Sectional Title Act and the Registered Conduct Rules of the complex. Schoongezicht is a gated complex and not a security complex, however, we do have patrols by Vetus Schola and Helderberg Crime Watch (HCW), and security cameras have been installed at points around the complex.

No instructions are to be given to our employees. Please contact the relevant Trustee or WatchProp (details above) to register a gardening or maintenance problem.


